The program works as follows: Collective donations at \$50,000 increments will be matched by the Province of Ontario. Half the annual payout on the resulting \$100,000 endowment will then be matched by University funds. In effect, each new fellowship attracts a 3:1 match to provide roughly \$6,000 per annum in perpetuity for the benefit of our graduate surgical students, when compared to \$2,000 without the match.
